What if I forget to pay my tax?



It happens. A due date slips by, you realise a payment has been missed, and you quickly make things right.

What surprises many people is that even when a tax payment is made only a day or two late, Inland Revenue can still apply late payment penalties and interest. Depending on the amount involved, those costs can add up faster than you might expect.

The good news is that if you act quickly, there may be options available. In some situations, tax pooling can help reduce or avoid penalties and interest, particularly where a payment has been overlooked but the tax was otherwise intended to be paid on time.

If you've missed a tax payment, or think you might, don't ignore it. The sooner you seek advice, the more options are likely to be available.
